BEING A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF INUVIK IN THE NORTHWEST TERRITORIES TO PROVIDE FOR THE REGULATION AND LICENCING OF LOTTERY SCHEMES WITHIN THE TOWN OF INUVIK

**PURSUANT TO** the *Cities, Towns and Villages Act*, S.N.W.T. 2003, c.22 and the *Lotteries Act*, R.S.N.W.T. 1988, c. L-11;

WHEREAS the Town of Inuvik has been granted the authority to regulate and licence lottery schemes pursuant to the *Lotteries Act*;

AND WHEREAS the Council of the Municipal Corporation of the Town of Inuvik deems it desirable to regulate lottery schemes within the Town of Inuvik;

**NOW THEREFORE BE IT RESOLVED** that the Council of the Municipal Corporation of the Town of Inuvik in the Northwest Territories, at a duly constituted session enacts as follows:

- 1. This by-law shall be cited as the "Lottery Regulations By-law."
- 2. No person, persons or organizations shall conduct a lottery scheme within the Town unless that person, persons or organization holds a lottery licence for that lottery scheme issued under this by-law.
- 3. The Town of Inuvik Lottery Regulations Policy MG.009 is hereby adopted and may be subsequently amended by Council resolution from time to time.
- 4. The Senior Administrative Officer shall cause to be kept a record of all applications for lottery licences and all lottery licences issued by the Town.
- 5. Upon being satisfied that an applicant is in compliance with this by-law and that the applicant is entitled to the licence applied for, the Senior Administrative Officer shall issue the licence to the applicant in a form approved by this by-law.
- 6. A Lottery Licence Application or amendment request made under this by-law shall be accompanied by the fee set out in the Town of Inuvik Fees and Charges Policy FM.021.
- 7. All funds received during each fiscal year, as outlined in this clause, shall be distributed as follows:
  - 1) First \$28,000 to the Town of Inuvik to offset costs incurred by the Town to administer this By-law.
  - Next \$10,000 to be distributed equally to the Inuvik Community Corporation and the Nihtat Gwich'in Council to assist each organization with funding of recreational and cultural programs for their respective members.
  - 3) All remaining funds received within each fiscal year shall be deposited to the Town of Inuvik's General Revenues to assist with recreational and cultural programs within the boundaries of the Municipal Corporation of the Town of Inuvik.
- 8. Notwithstanding Clause 6, where a single event bingo lottery or a series of bingo lotteries involves games which carry over jackpot amounts, only the amount of the opening jackpot shall be used to calculate the total value of prizes offered under the Lottery Regulations Policy MG.009.
- 9. Council may, by resolution, establish guidelines to assist with the administration of this By-law and such guidelines shall become those additional terms or restrictions the Town may impose on any licence in addition to those noted in the Town of Inuvik Lottery Regulations Policy MG.009.

- 10. The Senior Administrative Officer may revoke the lottery licence issued under this by-law where they are satisfied that:
  - a) The licence was issued in error whether due to misrepresentation or otherwise;
  - b) The licensee has breached the conditions of the licence; or
  - c) The licensee has violated the provisions of the by-law, or other applicable statutes or regulations.
- 11. Every person who contravenes any provision of the by-law is guilty of an offence and is liable on summary conviction(s) to a fine not exceeding two thousand dollars (\$2,000.00) or in default of payment of a fine to imprisonment for a term not exceeding six (6) months. Specified penalties for offenses under this by-law are listed in Schedule A attached to and forming part of this by-law.
- 12. By-law #2457/LOTT/08 and any previous lottery by-laws, regulations and policies in effect are hereby repealed.
- 13. This by-law will come into effect upon the day of its final passage.
