SPECIAL REQUIREMENTS

All Lotteries

- Refer to the Lottery Regulations and By-Law for information regarding the rules of your lottery scheme.

GENERAL INFORMATION

Under the Town of Inuvik Lottery By-Law, organizations which are deemed to be charitable or religious and which have charitable or religious objectives or purposes are eligible to hold licensed bingo lottery

The lottery must be managed and conducted in the manner described in the Lottery By-Law.

The proceeds must be used for the charitable or religious objectives specified in the application, as approved.

Where the total prizes awarded under a series license exceed \$100,000.00 an audited statement must be submitted.

Where the prize(s) in a single lottery are to exceed \$30,000.00 specific approval is required from council.

Fees will be due and payable within 30 days of the Licensing Committee's assignment of dates

Any groups which can not hold their assigned Bingos must notify the Lottery Officer within 5 business days of the date of the Bingo

The Lottery Officer will offer the Bingo to the next available group on the prioritized waiting list

Failure to host a bingo shall mean a forfeit of the license application fee.
