A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF INUVIK IN THE  
NORTHWEST TERRITORIES TO ALLOW EXEMPTIONS FROM MUNICIPAL TAXATION

---

Pursuant to Section 74 of the Property Assessment and Taxation Act of  
the Northwest Territories R.S.N.W.T. 1988, c.10, s.74(2)(h);

NOW THEREFORE BE IT RESOLVED that the Council of the Municipal  
Corporation of the Town of Inuvik in session duly assembled enacts as  
follows:

1. The municipal corporation of the Town of Inuvik may approve an  
exemption from municipal taxation to all land, improvements or mobile  
units used by an incorporated non-profit society, up to date in filing  
and registered under the Government of the Northwest Territories  
"Societies Act", except for any land, improvements or mobile units that  
is used as a residence provided that the society:

(a) Completes the application form contained in "Schedule A" attached  
to and forming part of this bylaw. and;

(b) Provides, in writing, proof that they are an incorporated  
society, up to date in filing and registered under the Government  
of the Northwest Territories "Societies Act".

READ A FIRST TIME THIS 4 DAY OF DECEMBER 1991, A.D.

READ A SECOND TIME THIS 11 DAY OF DECEMBER 1991, A.D.

READ A THIRD TIME AND PASSED WITH THE CONSENT OF THE MEMBER OF COUNCIL  
PRESENT THIS 11 DAY OF DECEMBER 1991, A.D.
