

**TOWN OF INUVIK
BY-LAW #2533/TAX/12**

**A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF INUVIK IN THE
NORTHWEST TERRITORIES TO PROVIDE FOR THE REDUCTION TO A PORTION OF
THE PROPERTY TAXES**

WHEREAS pursuant to section 85 (1) and (2) of the Property Assessment and Taxation Act, R.S.N.W.T. 1988, c. P-10;

AND WHEREAS the Council of the Municipal Corporation of the Town of Inuvik deems it desirable to reduce a portion of the 2012 property taxes of properties;

AND WHEREAS the property owner of Lot 1 & 15 Block 9 Plan 228 (9 Dolphin Street) experienced a loss as a result of a fire which damaged the improvement on the property; and

AND WHEREAS the property owner of Lot 6 Block 32 Plan 328 (10 Gwich'in Road) experienced a loss as a result of a fire which damaged the improvement on the property; and

AND WHEREAS the property owner of Lot 6 Ptn 13 Block 1 Plan 629 (2 Balsom Trailer Court) experienced a loss as a result of a fire which damaged the improvement on the property; and

AND WHEREAS the property lessee of Lot 1008 Quad 107/B7 Plan 3444 (Lions' Den) experienced a loss as a result of a fire which damaged the improvement on the property; and

AND WHEREAS the property lessee of Lot 58 Group 1355 Plan 707 (Lions' Den) experienced a loss as a result of a fire on Lot 1008 Quad 107/B7 which damaged the improvement on that property, the lessee wishes to surrender this lease; and

AND WHEREAS the damage was so significant as to render the improvements on all properties unfit for further use or occupation; and

NOW THEREFORE BE IT RESOLVED that the Council of the Municipal Corporation of the Town of Inuvik, in Council duly assembled, enacts as follows:

SHORT TITLE

1. This by-law may be cited as the "2012 Tax Reduction By-law".

APPLICATION

2. That reduces:
 - a) The amount of \$1,468.88 be granted against the 2012 property taxes on Lot 1 & 15 Block 9 Plan 228; and
 - b) The amount of \$1,200.64 be granted against the 2012 property taxes on Lot 6 Block 32 Plan 328; and
 - c) The amount of \$347.68 be granted against the 2012 property taxes on Lot 6 Ptn 13 Block 1 Plan 629; and
 - d) The amount of \$1,726.47 be granted against the 2012 property taxes on Lot 1008 Quad 107/B7 Plan 3444; and
 - e) The amount of \$750.97 be granted against the 2012 property taxes on Lot 58 Group 1355 Plan 707.


3. This by-law will come into effect upon the day of its final passage.


READ A SECOND TIME THIS 27TH DAY OF JUNE, 2012 A.D.
