BEING A BYLAW OF THE TOWN OF INUVIK IN THE NORTHWEST TERRITORIES TO AMEND AND CONSOLIDATE STREET NAMING BYLAW.

WHEREAS PURSUANT to the Municipal Ordinance Section 184(k) being Chapter M-15 of the Revised Ordinances of the Northwest Territories and amendments thereto authorizing a Municipality to name or change the name of streets, roads, places or drives.

Now therefore BE IT RESOLVED that the Council of the Town of Inuvik in session duly assembled enacts as follows

1. SHORT TITLE

This Bylaw may be cited as the Street Naming Bylaw.

2. NAMES

N.T. Road - From Tank Farm Road to Navy Road

Tank Farm Road - from N.T. Road to and including Lot 4 Block 75

Lagoon Road - from N.T. Road to Kingmingya Road

Navy Road - CFS Inuvik Operations Gateway to Franklin Road

Industrial Road - from Muskrat Street to Wolverine Road

Willow Road - from Muskrat Street to Bay Street

Mackenzie Road - from Navy Road to the junction of Loucheux Road and Airport Road

Kingmingya Road - from Lagoon Road to the south west corner of Lot 14 Block 18

Bonnet Plume Road - from Navy Road to Firth Street

Kugmallit Road - from Navy Road to Centennial Street

Franklin Road - from Navy Road to Distributor Street

Wolverine Road - from Navy Road to Centennial Street

Inuit Road - from Raven Street to Breynat Street

River Road - from Distributor to Duck Lake Street

Loucheux Road - from Firth Street to the junction of Mackenzie Road and Airport Road

Airport Road - from the junction of Loucheux Road and Mackenzie Road to Transport Canada, main Airport

Boot Lake Road - from Lot 1 Block 51 to Lot 16 Block 50

Cemetery Road - from Airport Road to Lot 1 Group 1355

High Road - from the northwest corner of Lot 17 Block 52 to Tower Street

Low Road - from northeast corner of Lot 16 Block 52 to Tower Street

Arctic Road - from the northeast corner of Lot 7 Block 55 to the southeast corner of Lot 8 Block 57

Muskrat Street - from Navy Road to Willow Road

Bay Street - from Navy Road to Willow Road

Raven Street - from Wolverine Road to Bonnet Plume Road

Dolphin Street - from Wolverine Road to Franklin Road

Union Street - from Kingmingya Road to Franklin Road

Centennial Street - from By-Pass Road to Bonnet Plume Road

Reliance Street - from Inuit Road to Franklin Road

Millen Street - from Mackenzie Road to Franklin Road

Firth Street - from Inuit Road to Kingmingya Road

Berger Street - from Kingmingya Road to Mackenzie Road

Breynat Street - from the south east corner of Lot 5 Block 34 to Kingmingya Road

Distributor Street - from River Road to Mackenzie Road including all of Block 16

Duck Lake Street - from Mackenzie Road to River Road

Bompas Street - from Loucheux Road to Mackenzie Road

Okpik Street - from High Road to Low Road

Tower Street - from High Road to Low Road

Carn Street - from Airport Road to the southwest corner of Lot 5 Block 59

Alder Drive - from the northeast corner of Lot 1 Block 47 to the northeast corner of Lot 44 Block 46

Carmichael Drive - from the southwest corner of Lot 2 Block 34 to the northwest corner of Lot 2 Block 35

Natala Drive - from Bompas Street to Loucheux Road

Tuma Drive - from the northeast corner of Lot 1 Block 79 to Loucheux Road

Spruce Hill Drive - from the southeast corner of Lot 8 Block 28 to northeast corner of Block 31

Tununuk Place - from Mackenzie Road bisecting property known as Lots 7 to 16 Block 30

Camsell Place - from Mackenzie Road to completion of circle around Block 29

Mackenzie Place - from Mackenzie Road to Mackenzie Road fronting Sir Alexander Mackenzie School

Council Crescent - from Mackenzie Road to Mackenzie Road in a crescent around Block 23

Marine By-Pass Road - from Navy Road to the junction with Airport Road

3. Bylaws 305 and 367 are hereby rescinded.

4. This Bylaw shall come into effect upon the day of Final Reading thereof.
