TOWN OF INUVIK
LOTTERY FEES

1. All lottery license fees are due and payable upon date of application and are non-refundable.
2. Any changes to the Lottery Fee Schedule will immediately apply to any application for a lottery scheme.

3. **Definitions for Bingo Games**

- a. **"50/50" Game** ~ 50% of the total card sales is retained by the house and the remaining 50% will be the prize payout. Examples of 50/50 games are: Half-the-House, Share-the-Wealth, and Bonanza games.
- b. **"1/3, 1/3, 1/3"** ~ 1/3 of the total cards sales will automatically go to the house
 1/3 of the total cards sales will automatically go to the accumulative game
 1/3 of the total cards sales is given away as a consolation prize

If a person wins within the set number called, the winner shall receive the accumulated amount only.

The 1/3 which was considered the consolation prize must be donated to a Youth or Elder group(s) outside of its organization within sixty (60) days after the last event date.

- c. **Progressive Game** ~ Starting with a set amount and increasing by a set amount plus one (1) number per event.

4. **Bingo Lottery Licenses**

The following license fees are payable for a single event bingo lottery or each lottery of a series of bingo lotteries:

- a. For games of:
 - i. **"50/50", "1/3, 1/3, 1/3" and Progressive Bingo, where not greater than six games are to be run during the lottery** \$20.00
 - ii. **"50/50", "1/3, 1/3, 1/3" and Progressive Bingo, where greater than six games are to be run during the lottery** \$10.00 per game
- b. for all other games, where the total value of the prizes offered is:
 - i. **\$1,250.00 or less** \$50.00
 - ii **greater than \$1,250.00** 10% of the total value of the prizes

7. **Nevada Ticket Lottery Licenses**

a. The license fee payable for each Nevada ticket lottery, whether a single event lottery or one of a series of lotteries that is held during a bingo or casino lottery is:

Hall Bingo.....\$150.00
Media Bingo\$ 50.00

b. The fee payable for a booth pursuant to *Section 14.2 (Nevada Ticket Lotteries)* license for a series of Nevada ticket lotteries where the booth or club license is for a period of six (6) months or less**\$450.00/month**
or portion thereof

8. **Casino Lotteries**

The license fee payable for each table or wheel game run during a casino lottery is:

.....**\$25.00/day**

9. **Raffle Lottery Licenses**

The license fee payable for a raffle, whether a single or multiple draw raffle, where the total value of the prizes offered is:

a. \$1,250.00 or less is**\$35.00**

b. greater than \$1,250.00 is**5% of the total value of the prizes**

c. The fee payable for a club room pursuant to *Section 16.13* and *Section 16.14 (Raffle Lotteries)* license for a series of raffle ticket lotteries where the club license is for a period of 6 months or less**\$100.00/month**
or portion thereof

10. **License Amendment or Cancellation Fee**

The fee payable for amending or canceling a license is:**\$25.00**

11. **Late Application**

The fee payable for processing an application submitted less than seven (7) days prior to the event is**\$50.00**
