

**TOWN OF INUVIK
BY-LAW #2598/LEG/16**

**A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF INUVIK IN THE
NORTHWEST TERRITORIES TO ADOPT A FEES AND CHARGES POLICY**

PURSUANT TO the relevant sections of the Cities, Towns and Villages Act, S.N.W.T. 2003, c. C-22, and particularly section 72 (e), which allows municipalities to establish, by by-law, fees or other charges for products, programs, services, public utilities, infrastructure and facilities provided by the municipality and for the use of property under the ownership, direction, management and control of the municipality;

WHEREAS the Council of the Municipal Corporation of the Town of Inuvik deems it expedient and wishes to both consolidate and update the various fees and charges to be collected by the Town of Inuvik;

NOW THEREFORE BE IT RESOLVED that the Council of the Municipal Corporation of the Town of Inuvik in Council duly assembled enacts as follows:

SHORT TITLE

1. This by-law may be cited as the "Fees and Charges By-law".

APPLICATION

2. The Town of Inuvik establishes and imposes fees for the provision of services and programs and the use of its property as specified in the Town of Inuvik Fees and Charges Policy FM.021 which may be amended from time to time by council resolution.
3. Where applicable, federal, territorial or other taxes will be added to the fees specified in Town of Inuvik Fees and Charges Policy FM.021.
4. Administration shall review the Town of Inuvik Fees and Charges Policy FM.021 at least once each year.

NON-PAYMENT OF FEES AND CHARGES

5. The fees and charges imposed on a person pursuant to the Town of Inuvik Fees and Charges Policy FM.021 constitute a debt owing to the Town. The collection of outstanding monies as stipulated in Financial Administration By-law 2530/GEN/12 and the Town of Inuvik Collection of Accounts Receivable Policy FM.016 shall apply.

SEVERABILITY

6. The provisions of this by-law are severable and the invalidity of any part of this by-law shall not affect the validity of the remainder of this by-law.


EFFECT


7. This by-law will come into effect upon the day of its final passage.
