### RENTAL UNIT OWNERS' AGREEMENT TO GUARANTEE PAYMENT FOR SERVICE IF REQUIRED

#### IMPORTANT – ARREARS, DISCONNECTION & TRANSFER TO PROPERTY TAXES

- Accounts that are more than 90 days past due may have water service disconnected.
- Unpaid utility charges may be added to the assessed property owner's property tax account at year-end and collected the same way as property tax arrears, under the Municipal Statutes Replacement Act, the Property Assessment and Taxation Act, and the Town of Inuvik Water and Sewer Administration By-law.
