

A BY-LAW OF THE MUNICIPAL CORPORATION OF THE TOWN OF INUVIK IN THE NORTHWEST TERRITORIES TO AMEND THE HIGHWAY TRAFFIC BY-LAW 2663-23

WHEREAS the Council of the Municipal Corporation of the Town of Inuvik has enacted Highway Traffic By-law #2663/TR/21 to regulate traffic, parking, and the use of municipal highways;

AND WHEREAS the Council wishes to regulate the operation of Mobile Food Vendors on municipal highways and right-of-ways;

NOW THEREFORE the Council of the Town of Inuvik, in a duly assembled meeting, enacts the following amendments to Highway Traffic By-law #2663/TR/21:

1. AMENDMENTS TO SECTION 2.0 - DEFINITIONS

Insert the following new definition:

"Mobile Food Vendor" means a person or business that prepares and sells food or beverages to the public from a self-contained motorized or towable unit (such as a food truck or trailer), whether stationary or mobile, and which is licensed under the Town's Business Licence By-law and authorized to operate under the Town's Mobile Food Vendor Policy.

2. ADD NEW PART AFTER SECTION 123- SPECIAL EVENTS:

PART 124 - MOBILE FOOD VENDORS

124.1 No person shall operate a Mobile Food Vendor on a municipal highway, sidewalk, or right-of-way without a valid Business Licence and written authorization issued pursuant to the Town's Mobile Food Vendor Policy.

124.2 Mobile Food Vendors may only operate in the designated locations approved by the Town and during the permitted hours set out in the Mobile Food Vendor Policy, unless otherwise approved by the Senior Administrative Officer (SAO).

124.3 Mobile Food Vendors must not:

- obstruct vehicle or pedestrian traffic;
- impede access to emergency lanes, hydrants, or building exits;
- operate in a location where a public or private event is taking place, unless consent is provided by the event organizer.

124.4 Mobile Food Vendors must comply with all applicable sections of this By-law, including parking, noise, waste disposal, and safety requirements.

124.5 A Peace Officer or the SAO may direct a Mobile Food Vendor to cease operations or relocate immediately if found in violation of this by-law or the Mobile Food Vendor Policy.

124.6 Failure to comply with this Part constitutes an offence subject to the penalties outlined in Schedule C.

3. AMEND SCHEDULE C – SPECIFIED PENALTIES

OFFENCE	PENALTY
Operating a Mobile Food Vendor without required approvals	\$500.00
Operating outside approved locations or hours	\$250.00
Obstructing traffic or access while vending	\$250.00
Failure to comply with direction of Peace Officer or SAO	\$250.00

4. SEVERABILITY

This amending by-law shall be read with and form part of Highway Traffic By-law #2663/TR/21. In the event of a conflict between this and any other by-law, the provisions of this by-law shall prevail. If any provision is found invalid by a court of competent jurisdiction, the remainder shall remain in force and effect.

READ A FIRST TIME THIS 13 DAY OF AUGUST, 2025.

READ A SECOND TIME THIS 13 DAY OF AUGUST, 2025.

READ A THIRD TIME AND FINALLY PASSED THIS 10 DAY OF SEPTEMBER, 2025.
